Notice regarding inviting application for NEET-PG-2018 qualified candidates for filling-up of vacant /unfilled PG(MD/MS) seats in Govt. and private Medical Colleges of the State for the academic session 2018-19 .

Pursuant to the letter No. V. 11012/05/2017-MEP dated 27th April 2018 received from the Under Secretary to the Government of India , Ministry of Health & Family Welfare , Nirman Bhawan, New Delhi vide which cut off percentile of NEET-2018 reduced 15th percentile taking them to 35 percentile for General category candidates , 30 percentile for Person with Disabilities category and 25 percentile for SC/ST/OBC category candidates for the academic session 2018-19 . The minimum qualifying percentile as prescribed by the National Board of Examinations, New Delhi in pursuance to aforesaid directions is as under :-

The application complete in all respect **alongwith bank draft drawn in favour of Principal, Indira Gandhi Medical College, Shimla amounting to Rs. 1500/- for General category candidates and Rs. 1000/- for SC/ST candidates must reach in the office of Principal, Indira Gandhi Medical College, Shimla –cum-Member Secretary Counselling Committee on or before 7.5.2018 upto 2:00 PM (Student Section)** beyond which no application shall be entertained. *The HPHS in-Service candidates are required to submit their application form alongwith NOC failing which their candidature will not be considered.* The Counselling to fill-up vacant /unfilled PG(MD/MS) seats through the Centralized Counselling Committee shall be held on 8.5.2018 at 11:30 AM onwards in the Auditorium of Indira Gandhi Medical College, Shimla.
