Please refer to your letter no.MMMCH/24/3783 dated 16.02.2024 whereby Compliance Report was furnished in respect of the deficiencies pointed out by the Post Graduate Medical Education Board (PGMEB) vide letter no.35/352(38)/2022-PGMEB/002850 dated 18.01.2024. In this regard, it is informed that the aforesaid Compliance Report was considered by the PGMEB. Based on the reply furnished by the college/ institute, approval of the PGMEB is hereby accorded in terms of Section 25(1) and 35(4) of NMC Act, 2019 and regulation 7(1) of the Maintenance of Standards of Medical Education Regulations, 2023 (MSMER-2023) for continuance of **three (3) seats** of the course of **MD (Pharmacology)** in respect of students being trained at the aforesaid medical college.

2. Henceforth, the standard of medical education shall be monitored by the PGMEB of NMC as per the provisions contained in the Post Graduate Medical Education Regulation-2023 (PGMER-2023), MSMER-2023, the guidelines contained in the Minimum Standard of Requirements for Post-Graduate Courses-2023 (PGMSR-2023). In future, medical colleges/ institutions will furnish the Annual Disclosure Report in the prescribed format to the PGMEB, NMC.

3. Further, as per the report of the Aadhaar Enabled Biometric Attendance System (AEBAS), there is deficiency of one Assistant Professor in the Department of Pharmacology. You are directed to take steps to fill up the vacant post of



Assistant Professor and inform the Postgraduate Medical Education Board of National Medical Commission within one month from the date of issuance of this letter.
