In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition of MS(Otorhinolaryngology) qualification for 02 seats in respect of students being trained at Maharishi Markandeshwar Medical College & Hospital, Kumarhatti, Solan under Maharishi Marakandeshwar University, Kumarhatti, Solan, Himachal Pradesh**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:
