
Sir/ Madam,

In this regard, it is informed that the aforesaid Compliance Report was considered by the Post Graduate Medical Education Board (PGMEB). Based on the reply furnished by the college/institute, approval of the PGMEB is hereby accorded in terms of Section 25(i) and 35(4) of NMC Act, 2019, for grant of **Recognition of MD(Paediatrics) qualification for 06 seats in respect of students being trained at Maharishi Markandeshwar Medical College & Hospital, Kumarhatti, Solan under Maharishi Marakandeshwar University, Kumarhatti, Solan, Himachal Pradesh**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the year 2022, upon which it shall have to be renewed.*
- (ii) *The procedure for 'Renewal of Recognition' shall be same as applicable for the award of recognition.*
- (iii) *Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Post Graduate Course of the said institute.*

2. The approval for Recognition of MD(Paediatrics) qualification for 06 seats is granted subject to applicability of amendments in NMC Regulations from time to time.
